## Producer's description

The Ademco, Model 2600EC, nom. sens. (S)=9% obs./m, photoelectric smoke detector uses an infra-red light emitter and detector pair to detect smoke. The detector is designed to provide open area protection and to be used with compatible control panels only.

Two LEDs on each detector illuminate to provide 360° visible alarm indication. In quiescent state the LEDs flash every ten (10) seconds indicating power is applied and the detector is operating. In alarm the detector has a latching feature causing the LEDs to illuminate continuously. The detector is reset from alarm state into the sense state by a momentary power interruption.

Activating an internal reed switch with a magnet may test the detector.
