## Producer's description

The Mack, Model SOL-100S-1(-2), 40mm/50mm/80mm/100mm/150mm/200mm, Solenoid Actuated Main Valves consist of a diaphragm actuated main valve assembly controlled by a solenoid type pilot valve. An in-situ sensitivity adjustment can be made to the needle valve to adjust the valve closing speed control.
